NOTE:

1. Nominations open on **Monday 12 August 2019** and must reach the Returning Officer of the AEC as outlined in the how to lodge nominations section listed in this form, not later than **12 Noon (AEST) on Monday 26 August 2019**.

Nominations cannot be withdrawn after **12 Noon (AEST) on Monday 2 September 2019**. Such withdrawal must be by notice in writing to the Returning Officer signed by the nominee and submitted by hand, post or facsimile or any other electronic means.

2. Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

3. Candidates may submit a statement to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer no later than **12 Noon (AEST) 2 September 2019** will be published. Candidate statements are restricted to a maximum of 400 words and sent as a word doc. Passport sized photographs should be sent as a jpeg doc. To assist candidates, a standard "Candidate Statement Form" is available for use at www.aec.gov.au

4. As a candidate you will be sent an acknowledgment by email.

5. It is your responsibility to ensure that your nomination is received by the Returning Officer **BEFORE** nominations close.
